### **NOTIFICATION BY ENFIELD COUNCIL TO PURSUE DISCUSSIONS WITH THE COMPANY AS PREFERRED DEVELOPMENT PARTNER FOR A UK REGENERATION PROJECT**

Further to the clarification announcement dated 3 November 2017, Pacific Century Premium Developments Limited (the “Company”) has received notification from London Borough of Enfield (“Enfield Council”) to pursue discussions with the Company as the preferred development partner (“Preferred Bidder”) for the property development project known as the Meridian Water Regeneration Project (the “Project”) in respect of a site in Enfield, London, United Kingdom.

Enfield Council will arrange a meeting with the Company to explain the terms upon which the Company will be appointed as Preferred Bidder. The Company will consider such terms and, if it thinks fit, will sign a confirmation whereupon the Company will proceed with the negotiations with Enfield Council to finalise the definitive agreements for the Project.

The Company will issue a further announcement if there is any material update or development.

This announcement is made by the Company pursuant to the inside information provisions under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.
